## 1 Introduction

### 1.1 About This Document

This document describes the following:

- Upgrade from SAP E-Sourcing 5.x and higher to SAP Sourcing 9.0
- Upgrade from SAP Contract Lifecycle Management (SAP CLM) 2.0 to SAP CLM 9.0

#### More Information

### 1.2 Before You Start

- Make a database backup to ensure that no data loss occurs if the upgrade fails.
- Ensure that the existing SAP Sourcing system is operational.
- Read through this guide and any further documentation referenced in it.



#### Caution

During the upgrade process, you will need to upgrade your database and NetWeaver implementation irreversibly. To avoid losing your data permanently, make sure you have appropriate backups.

#### Constructing an SAP Sourcing Login URL

At various points, this guide will instruct you to log in as a certain user. You can log in as a buy-side user, a sell-side user, the enterprise user, or the system user. You must connect to the system using a different URL depending on which user the instructions call for. This section explains how to construct the correct login URL for the specified user.

SAP Sourcing login URLs can be constructed as follows:

#### [protocol]://[hostname]:[port]/[context]/[login type]/[login path]

#### Table 2

[protocol]	http or https. Typically https for customer productive
	systems.
[port]	The [port] element is optional.

[context]	This is the context you defined during installation.
[login type]	Use one of the following, depending what user is called for in the instructions:
	<ul> <li>If the instructions call for a buy-side user, use fsbuyer.</li> </ul>
	• For a <b>sell-side user</b> , use <b>fsvendor</b> .
	• For the <b>system user</b> , use <b>fssystem</b> .
	• For the <b>enterprise user</b> , use <b>fsenterprise</b> .
[login path]	For <b>fsbuyer</b> , <b>fsenterprise</b> , and <b>fssystem</b> , this is <b>portal/login</b> .
	For <b>fsvendor</b> , this is <b>vendordesktop/login</b> .

#### Note

After the initial login, the system prompts you to change your password

#### **New Features** 1.2.1

This section describes new features that are not mentioned elsewhere in this guide.

#### Log On as System User via /fssystem Context

As of SAP Sourcing 7.0, you can log on as the system user only via the /fssystem context. You can no longer log on as the system user from the /fsbuyer context.

#### Log on as System User via /fsenterprise Context

As of SAP Sourcing 9.0, you can log on as the enterprise user only via the /fsenterprise context. You can no longer log on as the enterprise user from the /fsbuyer context.

#### Use System User to Create New Localized Resources When Moving Multi-Tenant Deployments

If you are moving multi-tenant deployments to SAP Sourcing 9.0, you must use the system user to create new localized resources if the resources are to be shared across all tenants. Previous to SAP Sourcing 7.0, you could use the enterprise/tenant user to do this.

#### **Global Search**

KM content search has been disabled as of SAP Sourcing 9.0. Use global search to carry out free-text content search on documents and attachments. This simplifies your landscape because global search does not require a TREX server. For information about global search, see SAP Library for SAP Sourcing on SAP Help Portal at

▶ help.sap.com/sourcing > SAP Sourcing 9.0 > Help for Purchasers > [choose a language] > Getting Started > General Functions > Global Search >.

#### Note 1

SAP recommends you deactivate the Global Search Channel if you are not using it, as this feature has been replaced with the Global Search button. Unlike earlier versions, the new Global Search filters the results to only those items that the user can open.

To be available for global search, any new or changed documents and attachments must be indexed. As of SAP Sourcing 9.0, the Search XML Extract scheduled task and the index refresh are coupled so that the index is refreshed as soon as the Search XML Extract scheduled task is complete. The index refresh is no longer a separate scheduled task. The Search XML Extract scheduled task is set to run once daily, starting around midnight.

#### **Symantec Antivirus**

If you have been using Symantec virus scanning and wish to continue doing so, you must update the location of the SymJavaApi.jar file in the configuration utility.

# 3 Planning

When planning the upgrade, take the following into consideration:

#### SAP NetWeaver 7.3 SP03

SAP Sourcing 9.0 requires SAP NetWeaver 7.3 SP03. For more information, see Before You Start [page 5].

#### **Hardware and Software Requirements**

#### **Database Backup**

Be sure to make a database backup before starting the upgrade to ensure that no data loss occurs if the upgrade fails.

#### **Write Down Current SAP Sourcing Version Number**

In order to perform the steps in section 5.5 "Import Upgrade Workbooks," you will need to know the version number of the version of SAP Sourcing you are upgrading **from**. Determine and write down this version number now, so you will have the information you need at the correct time.



#### Caution

In Chapter 5, "Upgrade Process," you will delete your current SAP Sourcing installation. You must know your SAP Sourcing version number before then, or it will be too late. You will be unable to determine the correct SAP Sourcing version number using these instructions.

Follow these instructions to determine your current SAP Sourcing version number:

- 1. In SAP Sourcing, navigate to Setup System Administration 1.
- 2. From the System Management section, choose System Information.
- 3. Your SAP Sourcing version number is located in the *Application Properties* table, in the row for *ESO Version*. Write it down for use in section 5.5 "Import Upgrade Workbooks."

#### **Upgrade Sequence**

You must carry out the upgrade in the order given in the previous chapter, Quick Guide.

#### **Integration of SAP ERP and SAP Sourcing**

This is relevant only if your source system is already integrated with SAP ERP.

### i Note

The is\_sapint\_installed system property indicates whether your SAP E-Sourcing system is already integrated with SAP ERP. You can check this system property as follows:

- 1. Log on to SAP Sourcing as the system user if you are upgrading from SAP E-Sourcing 5.x, or with the enterprise user if you are upgrading from SAP Sourcing 7.0.
- 2. Choose Setup.
- 3. Choose System Properties.
- 4. Locate the is\_sapint\_installed property below:

5. The value TRUE indicates that the system is enabled for integration.

#### **Upgrade from SAP E-Sourcing 5.x**

In SAP E-Sourcing 5.0 and 5.1, a package was available to integrate SAP E-Sourcing with SAP ERP. This package was based on custom development techniques, including the definition of extension fields and custom master data objects, and is not supported on releases beyond SAP E-Sourcing 5.1.

When you upgrade an SAP E-Sourcing 5.0 or 5.1 system that uses this integration package, a migration utility automatically converts the custom extension fields and data to the equivalent standard fields in SAP Sourcing 9.0. If the SAP E-Sourcing 5.0 or 5.1 system does not use the integration package, this migration does not occur.

The migration process marks all affected extension fields as inactive. After the upgrade is complete, reactivate any extension metadata that you want to retain.

After an upgrade acceptance test that includes a review of the migrated standard data, we recommend running a final script to delete the inactive extension data. For more information, see Run DB Importer Script to Delete Obsolete Data [page 50].

If you or your implementation consultant have customized the integration process by adding extension fields or scripts, or by editing the provided scripts, you may have to undertake further customization to be compatible with the integration design in SAP Sourcing 7.0 and higher. The migration process will not upgrade any non-standard fields or scripts.

#### **Configure Global Search If Necessary**

Due to enhancements as of SAP Sourcing 9.0 SP22, you may need to configure system properties and/or apply security profiles to configure Global Search functionality. For details, see the Configuration Guide for SAP Sourcing 9.0 at \$\rightarrow\$ service.sap.com/eso \$\rightarrow\$ SAP Sourcing On-Premise \$\rightarrow\$ SAP Sourcing 9.0 \$\rightarrow\$ Configuration Guide for SAP Sourcing 9.0 \$\rightarrow\$.

## 4.1 Run Query Tester Before Upgrade

#### **Procedure**

While the previous release is still running, execute the query tester utility for custom query definitions before the upgrade, so that the queries that have problems can be diagnosed without taking into account any changes introduced by the new release. You must execute the query tester utility again after the upgrade, using the procedure described in Run Query Tester After Upgrade [page 52].

- 1. Log on to SAP Sourcing as a user with system administration rights, specifically with access to importing and exporting data.
- 2. Choose Setup.
- 3. On the System Administration tab, find the Import and Export Tools section and click Import Data.
- 4. Choose New.
- 5. Select File Already Exists on Server.
- On the next page, enter classpath://scripts/upgrade/test\_custom\_queries.xml as the server file path.
- 7. On the next page, select Wait for Import to Finish.
- 8. Review the trace.txt file for errors.

### 4.2 Install and Configure DB2 Text Search

#### **Procedure**

Install and configure DB2 Text Search for the version of your database server (see below). This is required for the platform to be installed successfully. It is also required if you want to use global search.

For information about global search, see SAP Library for SAP Sourcing on SAP Help Portal at help.sap.com/sourcing SAP Sourcing 9.0 Help for Purchasers (choose a language) Getting Started General Functions Global Search.

Be sure to also install the DB2 Accessories Suite, which is required for the proper indexing of many formatted text documents such as Microsoft Word and Adobe PDF. Installation of the DB2 Accessories Suite is also described in the documentation specified below.

### i Note

If you are unable to install DB2 Accessories Suite on Windows systems where DB2 is installed in the default installation directory under <drive>:\Program Files, make sure that DB2 is installed in a non-default installation directory without any spaces in the installation directory path, for example, c:\IBMDB2V97.

#### IBM DB2 Version 9.7

In the IBM DB2 9.7 for Linux, UNIX, and Windows Information Center, choose Database Fundamentals Searching Text DB2 Text Search .

## 4.3 Verify Database User Account Settings

SAP Sourcing uses a database user account to connect to the database.

#### **Procedure**

- 1. Verify that at least the following database privileges are granted to this database user account:
  - o CONNECT
  - CREATETAB
  - o BINDADD
- 2. Verify that use of your tablespaces is granted to this database user account.

#### **More Information**

#### **Run Preconversion Reports** 4.4

It is rare for a release or support package to contain any preconversion reports. However, if it does, you must run all preconversion reports for the release in order to identify any data corrections that must be made in your current system before you start the upgrade.



#### Caution

If you do not make the necessary data corrections, the upgrade of the database will fail. If the upgrade of the database fails, you must start the upgrade process again using the database backup.

The preconversion reports are listed in the XML file cnv report queries.xml together with documentation for each report. The documentation describes how to interpret the results of the report.

To access any preconversion reports for SAP Sourcing 9.0, see SAP Note 1690280.

#### **Procedure**

If no preconversion reports are required, you can proceed with the upgrade preparation. Otherwise, run the preconversion reports according to the following procedure.

- Import the files as follows:
  - 1. Choose Setup or Administration, depending on your release.
  - 2. Under System Administration Import and Export Tools, choose Import Data.
  - 3. Choose Create and follow the wizard.
- Run the preconversion reports as follows:
  - 1. Under ▶ System Administration ➤ Administrative Reports → choose Conversion Reports.
  - 2. Run each report individually.
- 3. Compare the results of each report with the corresponding documentation for the report, and carry out any
- Rerun the preconversion report to confirm that you have addressed all previously identified issues.
- If you made changes to resolve issues, make a database backup again.

#### **Resize Company Logo** 4.5

#### **Procedure**

### Note

This step is necessary only if you are upgrading from SAP E-Sourcing 5.x to SAP Sourcing 9.0.

If you have uploaded a company logo in your source release, you must resize the image to 200x29 pixels so that it is supported by the user interface.

- 1. Log on to SAP Sourcing as a user with system administration rights.
- Choose Setup.

- 3. On the Master Data tab, find the Organization and Accounting Information section and click Companies.
- 4. Click the company.
- 5. Choose Edit.
- 6. In the Logo field, upload the resized image.

#### Note

If you added your company logo as a JAR file to the system property buylogoimage or selllogoimage in your source release, your company logo is no longer displayed after the upgrade. To restore your company logo, upload it in the correct size and to the correct location as described above.

Alternatively, you can restore your company logo as follows:

- 1. Choose Setup.
- 2. On the System Setup tab, find the User Interface section and click Themes.
- 3. Open your current default theme.
- 4. Upload your company logo under Branding.

### 4.6 Check System Property for Integration of SAP ERP

Some upgrade actions are necessary only if your source system is integrated with SAP ERP. If your source system is **not** integrated with SAP ERP, check that the following system properties do not exist, or that they are set to false.

- SAPINT.is\_sapint\_installed
- sapintegration.is\_sapint\_installed

#### **Procedure**

- 1. Log on with the system user.
- 2. Choose Setup.
- 3. On the System Setup tab, find the Configuration section and click System Properties.
- 4. If the property is\_sapint\_installed does not exist, no action is required.

  If the property is\_sapint\_installed exists and has the value FALSE, no action is required.

  If the property is\_sapint\_installed exists and has the value TRUE, set it to FALSE.

# 4.7 Preparation for Integration of SAP ERP and SAP Sourcing

This section is relevant only if your source system is already integrated with SAP ERP. See also:

#### 4.7.1 **Upgrade from SAP Sourcing 7.0**

#### Procedure

If the system is enabled for integration, then the integrated SAP ERP system must be maintained in another system property. You can check this property as follows:

- 1. Log on as a user that has access to enterprise-level system properties.
- 2. Choose Setup.
- 3. On the System Setup tab, find the Configuration section and choose System Properties.
- 4. Locate the property with the following characteristics:
  - Set: odp.doc
  - Property: odp.doc.integration.external\_system
- The value must represent the integrated SAP ERP system.

#### Note 1

It is important that the above property is maintained with a valid value. A missing property or an invalid value will cause the upgrade to fail.

#### 4.7.2 **Upgrade from SAP E-Sourcing 5.x**

#### 4.7.2.1 **Maintain Properties File**

#### **Procedure**

In the <SAP Sourcing home directory>/config directory, place a properties file with the name ES60ERPMigration.properties.



#### Caution

If this file is not created or edited properly, the upgrade is likely to fail.

#### **Map Value List Values to Transaction Types**

Use the following procedure to map the erp\_oa\_type and erp\_po\_type value list values in SAP E-Sourcing 5.x to the transaction type and subtype in SAP Sourcing 9.0. During the upgrade, this mapping is used to convert these value list values to standard transaction types.

- 1. Log on to SAP E-Sourcing 5.x as the enterprise user.
- 2. Choose Setup.
- 3. Under System Setup, find Master Data and choose Value List Types and Values from the dropdown. Then choose OK.

- 4. Choose Outline Agreement Type.
- 5. For each value list value, note down the value in the *Display Name* column.
- 6. Decide if this outline agreement type is a quantity contract, value contract, or scheduling agreement.

#### Note

In general, values starting with K are contracts, and values starting with L are scheduling agreements, but verify this with your SAP ERP consultant.

- 7. For each value list value, enter one of the following key/value pairs in the ES60ERPMigration.properties file, depending on whether this outline agreement type is a quantity contract, value contract, or scheduling agreement. Replace <VALUE> with the value that you noted down in step 5.
  - ERP TRANSACTION TYPE <VALUE>=ContractValue
  - ERP TRANSACTION TYPE <VALUE>=ContractQuantity
  - ERP TRANSACTION TYPE <VALUE>=SchedulingAgreement
- 8. Return to the value list type list and click *Purchase Order Type*.
- 9. For each value list value, note down the value in the Display Name column.
- 10. For each value list value, enter the following key/value pair in the ES60ERPMigration.properties file. Replace <VALUE> with the value that you noted down in step 9.

ERP TRANSACTION TYPE <VALUE>=PurchaseOrder

#### 1 Note

Ensure that all erp\_oa\_type and erp\_po\_type value list values are maintained in the ES60ERPMigration.properties file; otherwise the upgrade will fail.

#### **Identify Primary Subcontext (If Necessary)**

The context scope of the purchasing organization has changed from company scope in the SAP E-Sourcing 5.x integration to enterprise scope in the SAP Sourcing 9.0 integration. If there are multiple subcontexts within your enterprise (unlikely), only one subcontext can be the source of the SAP Sourcing 9.0 purchasing organization data. If there are multiple subcontexts, add the following single property representing the primary subcontext to the ES60ERPMigration.properties file. Note that the value is case-sensitive.

ERP PURCHASING ORG\_SCOPE=<subcontext\_external\_id>



### Example

ERP\_PURCHASING\_ORG\_SCOPE=manufacturing\_company

In this example, the subcontext external ID manufacturing\_company is found in the schema at FCI\_SYS\_CONTEXT.EXTERNAL\_ID.

#### Verify the Region Value List Value

SAP ERP Region master data was created as a value list value of type Region in the integration package in SAP Sourcing 5.x. The Display Name of this value list type was generated by concatenating the SAP ERP Region ID and Country ID in the following format: <RegionID> <CountryID>.

In integration package 6.x, SAP ERP Region was created as a new master data object called ERP Region. Successful migration of the 5.x Region value list value to the new ERP Region object relies on the Display Name of the Region value list value being in the format <RegionID>\_<CountryID>. Region value list values that do not follow this format might not be converted to the ERP Region objects during migration.

To ensure all 5.x Region value list values are converted to ERP Region objects during migration, verify that the Region value list values are in the format <RegionID> <CountryID> in the 5.x system.

### 4.7.2.2 Identify Customizations and Plan Retrofit

#### **Procedure**

- 1. Identify any customizations that you made when integrating SAP E-Sourcing 5.x with SAP ERP, for example, customizations to SAP ERP or SAP NetWeaver Process Integration (SAP NetWeaver PI).
- 2. Evaluate any such customizations to determine which are still needed or no longer needed in SAP Sourcing 9.0, and contact your consultant to check these customizations.
  - After the upgrade, you may have to retrofit any customizations that are still needed.

# 4.7.2.3 Synchronize Published SAP E-Sourcing Documents with SAP ERP Documents

#### **Procedure**

If an SAP E-Sourcing 5.x document, such as a contract, is published to SAP ERP, and the SAP E-Sourcing document is subsequently changed, the changed document should be published to SAP ERP before the upgrade so that the fields in the SAP E-Sourcing document are synchronized with the corresponding fields in the SAP ERP document.

If the changed document is not published to SAP ERP until after the upgrade, the differences in some field values between the original publishing and the post-upgrade publishing of the document will be treated as a validation error by SAP ERP.

In the event of an SAP ERP validation error after the upgrade, you must import acceptable field values to SAP Sourcing 9.0 and then republish the document to SAP ERP. You cannot use the SAP Sourcing 9.0 user interface to restore these fields to values that SAP ERP will accept.

In addition, we recommend publishing any outstanding RFP awards from SAP E-Sourcing 5.x to SAP ERP before the upgrade.

## 4.7.3 Back Up Production System Schema

#### **Procedure**

Back up the production system schema so that you can restore it if the upgrade fails. The combination of the migration of the integration of SAP ERP and your SAP E-Sourcing 5.0, 5.1, or 7.0 source system together with all other SAP Sourcing 9.0 schema changes increases the chance of some unexpected combination of data leading to an upgrade failure.

## 4.7.4 Test Upgrade on Copy of Production System Schema

#### **Procedure**

The integration of SAP ERP and your SAP E-Sourcing 5.0, 5.1, or 7.0 source system is migrated as part of the SAP Sourcing 9.0 schema changes. You cannot rerun the script file to upgrade the schema. There is no independent script to migrate the integration.

We strongly recommend testing the upgrade on a copy of the production system schema. There is no standard acceptance test for the migration, other than that the schema upgrade completes with no error messages. Review the migrated data that you care most about, especially any retrofitted customizations. One way to review the migrated data is to go to the list page of each object that was affected by the migration, and view one or more of the listed objects.

# 5 Upgrade Process

- 1. If you have not already done so, make a database backup to ensure that no data loss occurs if the upgrade fails.
- 2. SAP Sourcing 9.0 requires SAP NetWeaver 7.3 SP03. If your present release of SAP Sourcing is not installed on SAP NetWeaver 7.3 SP03, you must uninstall your current version of SAP NetWeaver and install SAP NetWeaver 7.3 SP03 as follows:
  - Uninstall your current version of SAP NetWeaver.
     For more information, see the installation guide for SAP NetWeaver 7.3 on SAP Service Marketplace at service.sap.com/installNW73.
  - 2. Install SAP NetWeaver 7.3 SP03.
    - For more information, see the installation guide for SAP NetWeaver 7.3 SP03 on SAP Service Marketplace at service.sap.com/installNW73.
  - 3. Create two separate database schemas (or even two separate databases) one for SAP Sourcing and one for SAP NetWeaver 7.3 SP03.
  - 4. Restore your extracted application data to the new database schema; configure SAP NetWeaver 7.3 SP03 on the other schema.
- 3. Upgrade database [page 21].
- 4. Deploy SAP Sourcing SCA file to application server [page 23].
- 5. Run upgrade workbooks [page 26].
- 6. Install language packs [page 25].
- 7. Update contract generation service to support Microsoft Office Word 2007 documents [page 28].
- 8. Update optimizer [page 30].

# 5.1 Uninstall Current SAP Sourcing Installation and Install SAP Sourcing 9.0

#### **Procedure**

#### Note

Make a note of what version of SAP Sourcing you are upgrading from. Later, you will need to select workbooks specific to your old SAP Sourcing version.

- 1. Back up the Sourcing home directory.
  - Also back up any folders where you may have saved custom JAR files, for example, the custom directory or lib directory.
- 2. If you have not already done so, undeploy SAP Sourcing.
- 3. To uninstall the existing SAP Sourcing software and install the new SAP Sourcing software, follow the instructions in "Uninstalling and Reinstalling SAP Sourcing" in the **Installation Guide for SAP Sourcing 9.0**,

located on the SAP Service Marketplace at service.sap.com/eso SAP Sourcing On-Premise SAP Sourcing 9.0 \( \)

#### Note

As of SAP Sourcing 9.0 SP17, SAP Sourcing no longer supports the native protocol for Symantec. Sourcing will only support the ICAP protocol going forward. Customers must set Symantec to use the ICAP protocol before installing this release. If customers change the port when changing to the ICAP protocol for Symantec, they must update the system.avscanner.port system property.

- 4. This step is necessary only if both of the following conditions are true:
  - Your source system is already integrated with SAP ERP.
  - You are upgrading from SAP Sourcing 5.0

If you have not done so already, place a properties file with the name ES60ERPMigration.properties in the <SAP Sourcing home directory>/config directory.

### 5.2 Upgrade Database

#### **Prerequisites**

You have made a database backup to ensure that no data loss occurs if the upgrade fails.

It is necessary to run the upgrade in the same locale (*Region and Language*) as will be used to run the application server. On Windows, NetWeaver is run as a service. Therefore in runs in the System Locale, this can be checked by bringing the *Region and Language* settings in the Control Panel. The language and location of the System Locale is found on the *Administrative* tab. The language and location of the current account can be found on the *Formats* and *Location* tabs respectively. On a Linux or UNIX system, the check is done by comparing the outputs of the "locale" command for each of the accounts.

#### **Revert Customized Properties to Standard Values**

#### Note

This procedure is necessary only if  $isc\_template$  and  $isc\_config$  have been customized.

- 1. In SAP Sourcing, navigate to ▶ Setup ➤ System Setup ➤ Integration ➤ Integrated System Configuration 1.
- 2. Under All Integrated System Templates change the customized templates to the default/standard.
- 3. Under All Integrated Systems change the customized configs to default/standard.

#### **Procedure**

#### **Run Script Files for SAP Sourcing**

1. Run the sourcing upgrade schema.xml script file as follows.



#### Caution

If you encounter errors when running the sourcing upgrade schema.xml script file, stop the upgrade and contact SAP Support. Do not rerun this script file.

- 1. From a command prompt, go to the /bin installation directory and enter **dbimport** to start the DB Importer utility.
- 2. On the Setup tab, select the fcieso.jar file.
- 3. Navigate to the com/sap/eso/odp/install/scripts/upgrade directory and select the sourcing\_upgrade\_schema.xml script file.
- 4. Open the input help dropdown for the Context field and choose System Context.
- 5. As user name, enter the system manager user **system** and enter the appropriate password.
- 6. Choose Run.
- 7. On the Script tab, verify whether the script run was successful (green check marks) or whether there were any errors (red crosses).

If there were any errors, stop the upgrade and contact SAP Support. Do not rerun the sourcing upgrade schema.xml script file.

#### Note 1

When this step has successfully completed, a large green check mark appears in the bottom right corner of the window. Even if you see check marks next to all items in the main body of the window, if you do not see the large green check mark at the bottom right of the window, this step has not executed successfully.

- 8. Exit the DB Importer.
- Run the sourcing upgrade data.xml script file as follows.
  - 1. From a command prompt, go to the /bin installation directory and enter **dbimport** to start the DB Importer utility.
  - 2. On the Setup tab, select the fcieso.jar file.
  - 3. Navigate to the com/sap/eso/odp/install/scripts/upgrade directory and select the sourcing\_upgrade\_data.xml script file.
  - 4. Open the input help dropdown for the Context field and choose System Context.
  - 5. As user name, enter the system manager user system and enter the appropriate password.
  - 6. Choose Run.
  - 7. On the Script tab, verify whether the script run was successful (green checkmarks) or whether there were any errors (red crosses). You can try the following to identify and remove errors:
    - Check and address any warnings or errors on the *Errors* tab.
    - Check the log files under the /logs folder in the home directory. Warnings are not saved to the error

After resolving the errors, rerun the sourcing upgrade data.xml script file, making sure that the context is set to system.

#### Note 1

When this step has successfully completed, a large green check mark appears in the bottom right corner of the window. Even if you see check marks next to all items in the main body of the window, if you do not see the large green check mark at the bottom right of the window, this step has not executed successfully.

#### Recovery After Correction of queries.xml File Import Errors

If errors occur during the import of any \*queries.xml files, a red X will appear for those import bundles and the *Product Queries DB Cleanup* action at the end of the query object import will not be executed, but the overall upgrade data script will continue. The schema will not have all the current query objects that are needed, and obsolete standard query objects from previous releases will still be active.

As an example of an error, a report that had its access restricted in a previous release to certain users or groups, which are then added to the report's access list, could fail to be imported if the only user who previously had edit privileges for the report is no longer an active user. A possible workaround for this is to temporarily reactivate the user so that a subsequent import attempt would succeed, and then to replace that user with a currently active one after the import.

If the conditions leading to the errors that are logged by the query importer are corrected in the schema being upgraded, a subsequent step is necessary to complete the imports and to run the *Product Queries DB Cleanup* action. This step is to run the com/sap/eso/odp/install/scripts/product/import\_all\_queries\_data.xml script. This script must complete successfully for a successful upgrade.

## 5.3 Deploy SAP Sourcing SCA File to Application Server

#### **Prerequisites**

You are familiar with the Java Support Package Manager (JSPM). For information about the JSPM, see SAP Help Portal, as follows:

- 1. Navigate to help.sap.com SAP NetWeaver SAP NetWeaver 7.3.
- 2. In the SAP NetWeaver Platform section choose SAP NetWeaver 7.3.
- 3. In the System Administration and Maintenance Information section, choose your language for the Technical Operations Guide.
- 4. In the Constraints section, choose Solution Lifecycle Management from the SAP NetWeaver Operations General Information row of the table.
- 5. Choose Software Logistics from the table.
- 6. In the Software Maintenance section, choose Java Support Manager from the Importing support packages row of the table.

#### **Procedure**

#### Note

Step 1 is necessary only if you copy the SCA files. If you point the JSPM to the directory with the SCA files instead of copying them, you can skip step 1.

1. Copy esoserver.sca from <SAP Sourcing home directory>/fsapp/ to the folder from which the JSPM reads the software components for deployment to the SAP NetWeaver application server. For example, <Drive>\usr\sap\trans\EPS\in (Windows) or \usr\sap\trans\EPS\in (UNIX).

This is the folder from which the JSPM reads the software components for deployment to the SAP NetWeaver 7.3 SP03 application server.

- 2. This step depends on whether you have copied the SCA files in step 1, or whether you want to point the JSPM to the directory with the SCA files.
  - If you have copied the SCA files in step 1, use the JSPM to deploy the SCA files to SAP NetWeaver 7.3 SP03 as follows:
    - 1. Navigate to <Drive>\usr\sap\<SID>\J00\j2ee \JSPM (Windows) or \usr\sap\<SID>\J00\j2ee \JSPM (UNIX) and launch the JSPM from go.bat (Windows) or go (UNIX).
    - 2. Log on to the JSPM using the SAP NetWeaver Administrator and password.
    - 3. In the Select Package Type step, select New Software Components and choose Next.
    - 4. In the *Specify Queue* step, select esoserver. Choose *Skip* to omit any other entities you do not wish to deploy.
    - 5. Choose Next.
    - 6. In the Check Queue step, choose Start.
  - If you want to point the JSPM to the directory with the SCA files, run the go script file as follows when you start the JSPM.

Only valid for: Windows |

go.bat "-config=\jspm\inbox=<path\_to\_sca\_files>"

End of: Windows |

Only valid for: UNIX |

go '-config=/jspm/inbox=<path\_to\_sca\_files>'

End of: UNIX |

Only valid for: UNIX |



go '-config=/jspm/inbox=/usr/sap/<SID>/esourcing/fsapp'

End of: UNIX |

- 3. Start the SAP Sourcing application from the SAP NetWeaver Administrator as follows:
  - 1. Launch the SAP NetWeaver Administrator.
  - 2. On the Operation Management tab, choose | Systems > Start & Stop > Java EE Applications ].
  - 3. Use the filter to find E-Sourcing.
  - 4. Select Sourcing and choose Start.
- 4. Launch the following URL and verify that the application is running:

http://<host\_name>:<port>/<context>/fssystem/portal/login

## 5.4 Install Language Packs

In SAP Sourcing, translated user interface strings are delivered as packages that you manually import using the DB Importer utility. If you are either already using translated strings or planning to add language support as part of your upgrade, follow these steps for each language that you require in your system.

SAP Sourcing supports the following languages:

- English
- Chinese, Simplified
- Czech
- Danish
- Dutch
- Finnish
- French
- German
- Hungarian
- Italian
- Japanese
- Korean
- Polish
- Portuguese (Brazilian)
- Russian
- Serbian (as of SP15)
- Slovak
- Spanish
- Swedish
- Turkish

#### **Procedure**

#### 1 Note

It is best to stop SAP Sourcing when executing this procedure. If you choose not to stop SAP Sourcing, then after you finish you need to refresh localized resources, as follows:

- 1. Log in as the system user.
- 2. Navigate to ▶ System Information ➤ Cache 3 tab.
- 3. Choose Refresh All
- 1. From a command prompt, go to the /bin installation directory and enter **dbimport** to start the DB Importer utility.
- 2. On the Setup tab, select the fci<language>.jar file (where <language> is the language that you want to install).

- 3. Navigate to the /i18n/ODP/<xx> directory (where <xx> is the language that you want to install) and select the install language.xml script file.
- 4. On the Setup tab, open the input help dropdown for the Context field and choose System Context.
- 5. As user name, enter the system manager user system and enter the appropriate password.
- 6. Choose Run.
- 7. On the *Script* tab, verify whether the script run was successful (green checkmarks) or whether there were any errors (red crosses). You can try the following to identify and remove errors:
  - Check and address any warnings or errors on the *Errors* tab.
  - Check the log files under the /logs folder in the home directory. Warnings are not saved to the error log.
- 8. On the Setup tab, select the fci<language>\_eso.jar file (where <language> is the language that you want to install).
- 9. Navigate to the /i18n/ESO/<xx> directory (where <xx> is the language that you want to install) and select the install language.xml script file.
- 10. Carry out steps 4 through 7 above.
- 11. Repeat as required for additional languages.

### 5.5 Import Upgrade Workbooks

Each new release delivers a set of upgrade workbooks that outline the changes to various master data and configuration objects. The upgrade workbooks are intended as a sample for you to tailor to your own implementations. You can access the upgrade workbooks from the index page of the Reference Guide. (To access the list of upgrade workbooks on the Reference Guide, log on to SAP Sourcing and choose Reference Guide Upgrade Workbooks

Each item in the resulting list of workbooks indicates the version number of SAP Sourcing it is relevant for. This is the SAP Sourcing version number you wrote down in chapter 3 "Planning," the version number of the SAP Sourcing version you are upgrading from.

For information about workbooks, including working with deployment workbooks, see "Workbooks" in the **Configuration Guide for SAP Sourcing 9.0** on the SAP Service Marketplace at service.sap.com/eso > SAP Sourcing On-Premise > SAP Sourcing 9.0 ...

#### **Procedure**

- 1. Determine the version number of the SAP Sourcing system you are upgrading FROM. This is the version number you wrote down in chapter 3 "Planning."
- 2. Log on as the enterprise user and navigate to Reference Guide Upgrade Workbooks 1.
- 3. Choose the Enterprise\_Upgrade workbook that is labeled for the version of SAP Sourcing you are upgrading from.
- 4. Review the Enterprise\_Upgrade workbook to ensure that all sample data is appropriate for your enterprise, then save it to your local system.
- 5. Import the Enterprise\_Upgrade workbook as follows:
  - 1. Navigate to ▶ Setup ➤ System Administration ➤ Import Data ▶.
  - 2. Choose New.

- 3. Select *Upload to Server*, then choose *Next*.
- 4. If desired, enter a description in the *Description* field.
- 5. Use the file picker to browse to the Enterprise\_Upgrade workbook you saved, then choose Next.
- 6. Choose Wait for import to finish, then choose Next.
- 7. Wait until Status is Complete the Percent Complete is 100, then choose Next.
- 8. Review the details presented, noting and correcting any failures.
- 6. Log off, then log on as a normal buy-side user and navigate to Reference Guide Upgrade Workbooks 1.
- 7. Choose the Company\_Upgrade workbook that is labeled for the version of SAP Sourcing you are upgrading from. Review the Company\_Upgrade workbook to ensure that all sample data is appropriate for your company.
- 8. Import the Company\_Upgrade workbook as follows:
  - 1. Navigate to Setup System Administration Import Data .
  - 2. Choose New.
  - 3. Select *Upload to Server*, then choose *Next*.
  - 4. If desired, enter a description in the *Description* field.
  - 5. Use the file picker to browse to the Company\_Upgrade workbook you saved, then choose Next.
  - 6. Choose Wait for import to finish, then choose Next.
  - 7. Wait until Status is Complete the Percent Complete is 100, then choose Next.
  - 8. When the message indicating the import is complete appears, choose *Finish* to view the import results.
  - 9. Review the details presented, noting and correcting any failures.

#### i Note

You do not need to import workbooks from releases prior to the release from which you are upgrading.

### 5.6 Convert .DOC and .DOT files to .DOCX and .DOTX

#### **Procedure**

In addition to supporting .doc, and .dot file formats, SAP CLM supports .docx and .dotx file formats. Typically, files in these formats are created with Microsoft Office 2007 or later. Since Microsoft soon will not support the .doc and .dot file formats, SAP recommends that SAP CLM users convert their existing .dot and .doc documents to the .docx and .dotx formats, and use only .docx and .dotx formats henceforth.

Please note also that, with new SAP Sourcing DOCX Generation service, CLM supports only .docx and .dotx formats.

Convert the legacy .doc and .dot files to .docx and .dotx respectively with the conversion script provided in DB Importer.

- 1. Find DB Importer on the Sourcing server, in the Sourcingbin subdirectory.
- 2. Invoke the DB Importer tool. For Linux servers, invoke dbimport.sh. For Windows servers, invoke dbimport.bat.
- 3. On the Setup tab, select the fcieso.jar file. Navigate to the com/sap/eso/odp/install/scripts/upgrade directory, and select the convert\_doc\_to\_docx.xml script file.

4. Run the upgrade script, *convert\_doc\_to\_docx*. This script converts all the existing contract .doc and .dot files to .docx and .dotx respectively.

#### **Alternate Conversion Process**

#### i Note

Use this process only if the script execution via DB Importer as guided above has been unsuccessful.

Follow these steps to convert the legacy .doc and .dot files to .docx and .dotx formats with the conversion script via a Scheduled Task of the type <code>Explicitly Called Script</code>.

- 1. Log in to SAP Sourcing as a purchaser.
- 2. Navigate to Setup System Setup System Properties 1.
- 3. Create or edit the system property contractgen.wordservice.enabled and set its value to TRUE.
- 4. Create or edit the system property contractgen.serviceurl and set its value to the correct Windows-based wordservice URL.
- 5. Navigate to Setup System Setup Explicitly Called Script .
- 6. Create a script to call the IAPI-enabled method convertDocToDocx() of the ContractBeanHomeIfc class. Here is a sample script:

```
Example
log = Logger.createLogMessage(session);
log.setLogMessage("Begin Conversion");
Logger.info(log);
maHome =
IBeanHomeLocator.lookup(session,com.sap.eso.api.contracts.ContractIBeanHomeIfc.sH
OME_NAME);

log.setLogMessage("End Conversion");
Logger.info(log);
```

- 7. Navigate to Setup System Setup Scheduled Task 1.
- 8. Choose New.
- 9. On the next screen choose Explicitly Called Script Execution.
- 10. Choose Continue.
- 11. Fill in all required fields. Make sure to set the *Frequency* field to *Run Once*. For the *Explicitly Called Script* field, choose the script created above.
- 12. Choose Done.

### **5.7 Update Contract Generation Service**

SAP Sourcing can use either the Microsoft .NET-based WordService or the SAP Sourcing DOCX Generation Service to generate structured clause documents, collection variables documents, and contract document templates.

The Microsoft .NET-based WordService requires setup of an additional Windows server. Due to this overhead and additional TCO, SAP Sourcing now also supports WordService based on JAVA technology, the SAP Sourcing

DOCX Generation Service. SAP Sourcing DOCX Generation Service does not require an additional Windows server. You must enable SAP Sourcing for either the .NET service or the SAP Sourcing DOCX Generation Service, not for both services.

#### i Note

Customers new to SAP Sourcing, and those who have not yet configured WordService, should set up the SAP Sourcing DOCX Generation Service.

We recommend also that customers with SAP Sourcing already installed and WordService already configured should update directly to the SAP Sourcing DOCX Generation Service as well. However, these customers may instead update Microsoft .NET WordService to the latest version.

Microsoft no longer supports Windows Server 2003. If your WordService currently runs on Windows Server 2003, we encourage you to use the new DOCX Contract Generation Service instead.

- To update your Microsoft .NET WordService installation to the current version, see Update Microsoft .NET WordService below.
- To update your contract generation service to the SAP Sourcing DOCX Generation Service, see Update
   Contract Generation Service to SAP Sourcing DOCX Generation Service below.

### 1 Note

Microsoft .NET WordService generates documents in .doc, .docx, .dot, or .dotx formats. The SAP Sourcing DOCX Generation Service generates and works with documents in .docx and .dotx formats only. For example, you cannot upload .doc or .dot files to the SAP Sourcing DOCX Generation Service. Therefore, to use the SAP Sourcing DOCX Generation Service, you must convert your legacy .doc and .dot files to .docx and .dotx formats.

#### **Prerequisites**

You have installed Microsoft Office Word 2007 (12.0.6612.1000) SP3 MSO 12.0.6607.1000 or Microsoft Office Word 2010 14.0.6129.5000 on the contract generation server.

#### **Procedure**

#### **Update Microsoft .NET WordService to Latest Version**

- 1. Take a backup of the web.config file from WordService installation directory.
- 2. Uninstall the existing WordServcie server.
- 3. Install the latest WordService server as follows:
  - Log on as a member of the administrator group.
     The setup program for contract generation is provided on the distribution media.
  - 2. Run the WordServiceInstaller.msi install program.
  - 3. Enter the virtual directory and site where the Web service is to be installed.
    The location is selected automatically based on the site you select. On the Internet Information Services (IIS) server, the default site is created in the following folder:
    c:\inetpub

This information is required to properly configure the FCI application to communicate with the service.

4. Update the new web.config file with any custom changes you may have made to the earlier web.config file. Most importantly, update the identity section of the new web.config file.

#### Update Contract Generation Service to SAP Sourcing DOCX Generation Service

To use the SAP Sourcing DOCX Generation Service, you must first convert all legacy contract clauses, collection variables documents, and contract document templates to .docx and .dotx formats. Therefore, you must have the .NET WordService enabled in order to convert these document types. Make sure .NET WordService has been upgraded to version 9.0 SP11 or higher. After the conversion, disable .NET WordService.

#### Recommendation

Before converting the files, take a backup of your entire database.

Do not disable the .NET WordService until you have tested the SAP Sourcing DOCX Generation Service and checked your documents thoroughly.

- 1. Log on as a member of the administrator group.
- 2. Make sure WordService is enabled by selecting Setup System Properties Contractgen.wordservice.enabled \(\).

#### Note 1

If Contractgen.wordservice.enabled is not listed, create the property by clicking New and adding it. Then, if the DB Importer is run with the system context, set this property in the system portal.

- 3. Select *Edit*. In the *Value* field, type **TRUE**, then choose *Save*.
- 4. Convert the legacy.doc and .dot files to .docx and .dotx, respectively, with the conversion script provided in the DB Importer. For more information, see Convert .DOC and .DOT files to .DOCX and .DOTX [page 27].

#### Note 1

This step is mandatory for all existing customers, because collection and advance object reference variable template files might exist in .DOC format as originally delivered with SAP Sourcing.

- 5. After testing the SAP Sourcing DOCX Generation Service thoroughly, and after checking your documents, disable WordService by selecting Setup > System Properties > Contractgen.wordservice.enabled 1.
- 6. Select *Edit*. In the *Value* field, type **FALSE**, then choose *Save*.

#### **Update Optimizer** 5.8

#### **Procedure**

This is necessary only if you used the optimizer in your source release.

- 1. Uninstall the existing SAP Sourcing software on the optimizer server.
- Install the new SAP Sourcing software on the optimizer server.

3. Redeploy the Optimizer SCA file, as described in "Install Optimizer" in the **Installation Guide for SAP Sourcing 9.0** on the SAP Service Marketplace at ▶ service.sap.com/eso ➤ SAP Sourcing On-Premise ➤ SAP Sourcing 9.0 ■.

# 6.1 Synchronize SAP Sourcing Timezone with OS, DB, and JVM Timezones

To avoid data loss, one of the following must be true:

- The timezones in SAP Sourcing, your OS, your database, and your JVM all accommodate daylight savings time; or
- None of those timezones accommodate daylight savings time.

#### **Set the SAP Sourcing Timezone if Necessary**

Bring the SAP Sourcing timezone into agreement with the timezones for your OS, your DB, and your JVM by setting the system.master timezone system property, as follows:

- 1. Log in as the system user.
- 2. Choose System Properties.
- 3. Do one of the following:
  - o If the system.master timezone is already in the list, click on its name, then choose Edit.
  - If the system.master timezone property is not already in the list, add it as follows:
    - 1. Choose New.
    - 2. In the Set dropdown, select system.
    - 3. In the Name dropdown, select system.master\_timezone.
- 4. In the *Value* field, enter a Java timezone value that aligns with your OS, your DB, and your JVM with regards to observation of Daylight Savings Time.
- 5. Choose Done.

#### 6.2 **Update Import Statements in Existing Custom Scripts** and Workflow Scripts

#### **Procedure**

As of SAP Sourcing 7.0, all classes in the system have been repackaged from com.frictionless to com.sap.odp or com.sap.eso.

To use the new packages, you must update all import statements in any existing custom scripts, workflow scripts, or custom JAR files.

You can use the convert\_workflows\_script\_definitions\_OnD.xml script file to replace com.frictionless with com.sap.odp or com.sap.eso in custom scripts and workflow scripts in the database. The script file does not handle custom JAR files.



#### Caution

We do not guarantee 100% accuracy with the convert workflows script definitions OnD.xml script file because it is not possible for us to know how you have created your custom scripts and workflow scripts.

You can run the convert workflows script definitions OnD.xml script file as follows.

- 1. From a command prompt, go to the /bin installation directory and enter dbimport to start the DB Importer utility.
- 2. On the Setup tab, select the fciinstall.jar file.
- 3. Navigate to the /scripts/upgrade directory and select the convert\_workflows\_script\_definitions\_OnD.xml script file.
- 4. Back on the Setup tab, open the input help for the Context field and choose System Context.
- 5. As user name, enter the system manager user system and enter the appropriate password.
- 6. Choose Run.
- 7. On the Script tab, verify whether the script run was successful (green checkmarks) or whether there were any errors (red crosses). You can try the following to identify and remove errors:
  - Check and address any warnings or errors on the *Errors* tab.
  - Check the log files under the /logs folder in the home directory. Warnings are not saved to the error log.

After resolving the errors, rerun the convert\_workflows\_script\_definitions\_OnD.xml script file, making sure that the context is set to system.

#### **Update Existing Custom Scripts and Existing Custom** 6.3 **JAR Files**

#### **Procedure**

When you upgrade from SAP Sourcing 5.x to SAP Sourcing 9.0, the following localized master data is converted to multi-string master data to reduce the resource cache and to provide more direct access to the localized values.

## **Update Existing Custom Scripts**

Test each part of the system where you have implemented custom scripts. If there are any problems with the execution of the script, update the script definition. Errors in the script definition can be found in the SAP Sourcing log files. To access the script definition, view the scripts via the SAP Sourcing user interface and edit them there.

#### **Update Existing Custom JAR Files**

If you have deployed a custom JAR file that includes custom code, recompile the JAR file using SAP Sourcing 9.0. Correct any compilation errors. You can contact SAP Professional Services to help you if necessary.

If you are using a custom JAR file that includes either a project import capability or a contract document import capability, you can stop using the custom JAR file, and begin using the standard product functionality to import projects and contract documents.

# 6.4 Update Single Sign-On Directory Configurations

#### **Procedure**

Since SAP Sourcing 7.0, the use of an authenticator for SAP NetWeaver single sign-on is no longer necessary. Use the SAP User Management Engine (SAP UME) driver instead. For information about configuring the SAP UME driver, see "Set Up Directory Configurations and Cluster" in the **Configuration Guide for SAP Sourcing 9.0** on the SAP Service Marketplace at service.sap.com/eso SAP Sourcing On-Premise SAP Sourcing 9.0 .

# 6.5 Update Theme

#### **Procedure**

## i Note

This step is necessary only if you are upgrading from SAP E-Sourcing 5.0 or 5.1 to SAP Sourcing 9.0.

If you have customized the user interface (UI) of your source release by customizing the theme, the theme will be set back to the default theme during the upgrade. This is to avoid incompatibilities between existing themes and new UI styles. In addition, the theme library has been restructured to make it easier and faster to customize themes.

You can duplicate the default theme, customize it, and then set it as the default, as described in SAP Library for SAP Sourcing on SAP Help Portal at help.sap.com/sourcing > SAP Sourcing 9.0 > Help for Purchasers > [choose a language] > Setup > System Setup > User Interface > Themes \( \) Your existing theme is retained for you to consult. You must also customize the theme if you want to customize the branding images.

# **6.6.1.1** Implement Standard Integration Components

The SAP ERP standard integration components are delivered with support packages or via SAP Notes, and are listed in the **Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0** on the SAP Service Marketplace at Sap Service.sap.com/eso SAP Sourcing On-Premise SAP Sourcing 9.0

If your SAP ERP release and support package are lower than those shown in the configuration guide, implement the standard integration components either by implementing the corresponding support package or by implementing the SAP Notes.

# 6.6.1.2 Import Process Integration Content to Integration Repository

#### **Procedure**

Follow the steps in "Import Process Integration Content to Integration Repository" in the **Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0** on the SAP Service Marketplace at **SAP Sourcing On-Premise** SAP Sourcing 9.0 **3**.

#### 6.6.1.3 **Configure SAP NetWeaver Process Integration**

#### **Procedure**

You can configure SAP NetWeaver Process Integration 7.1 (SAP NetWeaver PI 7.1) or higher either by creating a new configuration scenario or by modifying the existing configuration objects. Choose one of the procedures below.

To configure SAP NetWeaver Process Integration 7.0 (SAP NetWeaver PI 7.0), we recommend creating a new configuration scenario.

## **Create New Configuration Scenario**

- 1. Delete all existing configuration objects in the configuration scenario for the integration of SAP ERP and SAP Sourcing, and delete the configuration scenario itself.
- 2. In the change list, activate all configuration objects in the configuration scenario, and activate the configuration scenario. To do this, expand the change lists on the Change Lists tab, right-click your change list, and choose Activate. In the dialog box that appears, choose Activate.
- 3. Create a new configuration scenario for the integration of SAP ERP and SAP Sourcing. To do this, follow the steps in "Configure Integration Scenarios" in the Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0 on SAP Service Marketplace at > service.sap.com/eso > SAP Sourcing On-Premise > SAP Sourcing 9.0 \(\bigs\_{\text{.}}\)
- 4. Create configuration objects for each required integration scenario. To do this, follow the steps to configure each integration scenario and steps to configure communication channels for each integration scenario in the Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0 on the SAP Service Marketplace at service.sap.com/eso > SAP Sourcing On-Premise > SAP Sourcing 9.0 \( \).



### Example

To create configuration objects for the Send Material Master from SAP ERP to SAP Sourcing scenario, follow the steps in the sections entitled "Configure Integration Scenario for Send Material Master from SAP ERP to SAP Sourcing" and "Configure Communication Channel for Send Material Master."

## 6.6.1.4 Remove Implementation of Business Add-In BADI\_BBP\_ES\_CHANGE\_DATA

As of SAP Sourcing 7.0, suppliers can be integrated with more than one SAP ERP System. Integrating SAP Sourcing suppliers with multiple SAP ERP systems previously required implementing the BAdI BADI\_BBP\_ES\_CHANGE\_DATA to change the external ID of Company Code and Purchasing Organization master data. That manipulation of external ID is no longer needed in SAP Sourcing 9.0. Remove the BAdI implementation done for this purpose.

#### **Update Names and Descriptions of Price Conditions** 6.6.1.5

## **Procedure**

Your price condition IDs are transferred from SAP Sourcing 7.0 to 9.0 during the upgrade. However, the price condition names are replaced by a dummy name, which you should update after the upgrade. In addition, there is now a description field, which you can use, for example, to explain to your suppliers how the price condition is used in the RFx process. For information about how to update the name and add a description, see "Create Price Conditions in SAP Sourcing" in the Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0 on SAP Service Marketplace at | service.sap.com/eso > SAP Sourcing On-Premise > SAP Sourcing 9.0 1.

Alternatively, you can extract the pricing condition types from SAP ERP, and import them to SAP Sourcing. Note that only the IDs and names are extracted and imported to SAP Sourcing because there is no description field in SAP ERP. For information about how to do this, see "Extract Customizing Data from SAP ERP" and "Carry Out Initial Load of Customizing Data to SAP Sourcing" in the Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0 on SAP Service Marketplace at | service.sap.com/eso > SAP Sourcing On-Premise > SAP Sourcing 9.0 \(\).



#### Recommendation

For each price condition, we recommend entering a description in SAP Sourcing. This description can be longer than the name that is extracted from SAP ERP.

# 6.6.2 Upgrade from SAP E-Sourcing 5.x

This section is relevant only if you are upgrading from SAP E-Sourcing 5.x.

# **6.6.2.1** Retrofit Customizations (If Necessary)

The SAP E-Sourcing — SAP ERP integration package in SAP E-Sourcing 5.x was based on custom development techniques, including the definition of extension fields and custom master data objects. Most of the extension fields and custom master data objects have been replaced by new standard fields and standard master data objects in higher releases starting from SAP Sourcing 6.0. Customers could have added additional extension fields to support their integration in SAP E-Sourcing 5.x. This extension data and metadata won't be directly affected by the upgrade, but further customization work might have to be done to be compatible with the SAP Sourcing 9.0 integration design. There could be custom scripting and/or extensions that depend on teh SAP E-Sourcing 5.x integration extensions.

#### **Procedure**

## Adapt Your Own Scripting or Other Code to Changed Object Type

The migration will attempt to change the class ID of your own extension object references to the SAP E-Sourcing 5.x integration objects whose object type is changed, for example, purchasing organization. If you have any scripting or other code that processes these extension fields, you will probably need to adapt them to handle the changed object type.

#### Move Desired Extension Fields to Object That Will Not Be Deleted

If any SAP E-Sourcing 5.0 or 5.1 extension field values are owned by objects that will be deleted, but that you want to save (even if they will be ignored by the SAP Sourcing 9.0 integration code), you should move them to an object that will not be deleted. Of particular concern are any of your own extension fields that are owned by the material object. They will be lost for any material whose plants were re-parented during material consolidation.

# **6.6.2.2 Update Business System Object**

During the upgrade, a new master data object *Business System* is created. This master data object represents the single SAP ERP system that is integrated with the SAP E-Sourcing system being upgraded. During the upgrade, default values are entered in the *External ID* and *Display Name* fields of this object. After the upgrade, you should update these values to more meaningful values representing the integrated SAP ERP system.

#### **Procedure**

- 1. Log on to the SAP ERP system that is integrated with the SAP E-Sourcing system being upgraded.
- 2. In transaction <code>SALE</code>, <code>choose</code> | Basic Settings > Logical Systems > Assign Logical System to Client 1.

- 3. Select the client representing the integrated SAP ERP system and choose *Details*.
- 4. Note the value of the Logical System field. Generally, it is in the format <System ID>CLNT<Client Number>.

### i Note

Keep this value handy. You will need it below and later on.

- 5. Log on to SAP Sourcing as the enterprise user.
- 6. Choose Setup.
- 7. On the System Setup tab, find the Integration section and click Business Systems.
- 8. Click the single business system that is listed and choose *Edit*.
- 9. In the External ID field, enter the value noted in step 4.
- 10. For the *Name* and *Description* fields, choose the desired language from the dropdown and enter a name and description in that language.
- 11. Save your entries.
- 12. Repeat steps 5 to 11 for each enterprise context.

# 6.6.2.3 Define System Property for Default Integrated Business System

In this step, you define a system property for the business system to be used as the default integrated SAP ERP system.

If integration of suppliers from multiple SAP ERP systems is enabled, this system represents the SAP ERP system that is integrated with SAP Sourcing for business documents.

#### **Procedure**

- 1. Log on to SAP Sourcing with any user that has access to enterprise-level system properties.
- Choose Setup.
- 3. On the System Setup tab, find the Configuration section and click System Properties.
- 4. Choose New.
- 5. Create the system property as shown in the following table.

# 6.6.2.5 Maintain Number Range for Vendor Account Groups

As of SAP Sourcing 7.0, the vendor account group is modeled as a master data object with a *Number Range* field.

Since number range data was not previously available in vendor account groups, the number range is set to the default value *External* during the upgrade. After the upgrade, you must revisit each vendor account group and make sure that the number range is set to the same value as in SAP ERP.

#### **Procedure**

- 1. Log on to SAP ERP.
- 2. In Customizing for Financial Accounting (New) (transaction SPRO), choose ▶ Accounts Receivable and Accounts Payable ➤ Vendor Accounts ➤ Master Data ➤ Preparations for Creating Vendor Master Data ➤ Assign Number Ranges to Vendor Account Groups ■.
- 3. For each vendor account group that is integrated with SAP Sourcing, check whether the number range is set to internal or external.

#### Note

You can identify which vendor account groups are integrated with SAP Sourcing by comparing the vendor account groups in SAP ERP with the vendor account groups in SAP Sourcing.

- 1. Note the number range (for example, 01) of the vendor account group.
- 2. Open the value help (F4) for the Number Range field.
- 3. In the value help, locate the number range and check the value in the *Ext* column for that number range. If the value is *X*, the number range is external. If the value is blank, the number range is internal.
- 4. Log on to SAP Sourcing with any user that has authorization to change vendor account groups.
- 5. Choose Setup.
- 6. On the Master Data tab, find the Organization and Accounting Information section and click Vendor Account Group.
- 7. For each vendor account group, check whether the value in the *Number Range* column matches the value in SAP ERP. If it does not, click the vendor account group, choose *Edit*, and select *Internal* or *External* to match the value in SAP ERP.
- 8. Save your entries.

# **6.6.2.6** Implement Standard Integration Components

#### **Procedure**

The SAP ERP standard integration components are delivered with support packages or via SAP Notes, and are listed in the **Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0** on the SAP Service Marketplace at service.sap.com/eso SAP Sourcing On-Premise SAP Sourcing 9.0 .

If your SAP ERP release and support package are lower than those shown in the configuration guide, implement the standard integration components either by implementing the corresponding support package or by implementing the SAP Notes.

# 6.6.2.7 Configure Integration of SAP ERP and SAP Sourcing

## **Basic Configuration in SAP Sourcing**

Follow the steps in "Basic SAP Sourcing Configuration" in the **Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0** on SAP Service Marketplace at service.sap.com/eso SAP Sourcing On-Premise 
SAP Sourcing 9.0 . with the following exceptions.

• In *Edit Integrated System Configuration*, copy the values from the SAP E-Sourcing 5.0 or 5.1 integration configuration object to the corresponding fields in the SAP Sourcing 9.0 integrated system configuration object. ## **Basic Configuration in SAP NetWeaver Process Integration**

Follow the steps in "Basic Configuration in SAP NetWeaver Process Integration" in the **Configuration Guide for the Integration of SAP ERP and SAP Sourcing 9.0** on SAP Service Marketplace at service.sap.com/eso > SAP Sourcing On-Premise > SAP Sourcing 9.0 , with the following exceptions.

- In Set Up System Landscape Directory, skip the step to register the SAP ERP system in the System Landscape Directory (SLD) and the step to create a business system for the SAP ERP system because they already exist in your SLD.
- Follow the steps to register the SAP Sourcing system in the SLD and to create a business system for the SAP Sourcing system. As the new SAP Sourcing business system name, reuse the business service name that you used for your SAP E-Sourcing 5.0 or 5.1 system.
- Skip Define RFC Destination and Port because the RFC destination and port already exist.

## → Recommendation

After you have configured the new integration scenarios, we recommend deleting the SAP E-Sourcing 5.0 or 5.1 integration scenarios before you test the new integration scenarios because the SAP E-Sourcing 5.0 or 5.1 integration scenarios may conflict with the new integration scenarios.

  - SAP ERP 6.0 and above support only IDoc basic MATMAS05. If a lower IDoc type was used for your SAP E-Sourcing 5.0 or 5.1 integration, change the basic type to MATMAS05.
- "Configure Integration Scenario for Send Material Master from SAP ERP to SAP Sourcing"
- "Configure Communication Channel for Send Material Master"
- "Create Scheduled Tasks to Import XML Messages for Materials"

  - Skip steps 1 and 2. In step 3, modify the receiver port for message type CREMAS to choose the new port for the vendor that you created in "Maintain Port Definition."

- SAP ERP 6.0 and above support only IDoc basic CREMAS05. If a lower IDoc type was used for your SAP E-Sourcing 5.0 of 5.1 integration, change the basic type to CREMAS05.
- "Configure Integration Scenario for Send Vendor Master from SAP ERP to SAP Sourcing"
- "Configure Communication Channel for Send Vendor Master from SAP ERP to SAP Sourcing"
- "Create Scheduled Tasks to Import XML Messages for Vendors"

Follow the steps in "Configure SAP ERP RFQ to SAP Sourcing RFP" with the following changes:

- In "Configure IDoc for RFQ", skip steps 1, 2, and 3 because the ABAP RFC destination for the SAP NetWeaver Process Integration (SAP NetWeaver PI) system, logical system for the SAP NetWeaver PI system, and transactional RFC port already exist from your previous integration. In step 4, use the existing partner profile for message type REQOTE and modify it with the values provided in the configuration guide.
- In "Configure RFQ Output", skip steps 1 to 4 because your existing configuration for output control will work.
- Skip the step "Create RFx Template for SAP ERP Integration," as your template from SAP E-Sourcing 5.0 or 5.1 integration will continue to be used.

Follow all steps in "Configure SAP Sourcing RFP Award to SAP ERP Purchase Order."

Follow all steps in "SAP Sourcing RFP Award to SAP ERP Outline Agreement."

Follow all steps in "Configure SAP Sourcing Agreement to SAP ERP Outline Agreement."

# 6.6.2.8 Run Report BBP\_ES\_MIGRATE\_OA\_DOC

#### Procedure

Run report BBP\_ES\_MIGRATE\_OA\_DOC in your SAP ERP system. This report sets the status to M for outline agreements that are replicated from SAP Sourcing.

# **6.6.2.9 Update Product Categories**

The SAP E-Sourcing 5.x product categories do not contain any data that identifies them as SAP ERP-integrated product categories. Therefore, all these product categories are treated as local product categories during upgrade. After upgrade, the SAP ERP-integrated product categories must be updated with the appropriate SAP ERP business system information.

In SAP Sourcing 9.0, the CSV importer of the master data object is able to convert the local data to the replicated ERP data.

## **Procedure**

- 1. Identify the list of Product Category objects in the system that are currently local and should be replicated objects from ERP by the customer's knowledge.
- 2. Construct a CSV file with the following fields:

Table 20

CATEGORY_ID	This field should have the external IDs of the product categories that are currently local and that need to be converted to replicated data from certain external business system.
BUSINESS_SYSTEM	This field should have the external business system's ID, to which the data is converted.
CONVERT_TO_REPLICATED	This is a flag to indicate whether the data in the current row needs to be converted. TRUE means conversion is needed. If this field is empty, the default value is FALSE.

- 3. Log on to system setup as a user who has master data super user rights with the permission to edit integrated master data.
- 5. Create a new import, and the import process is the same as normal data import:
  - 1. Choose the constructed CSV.
  - 2. Select the Product Category object.
  - 3. Start the data import.

During the import process, the specified data in the CSV is converted to replicated data from the specified business system.

# 6.6.2.10 Update Payment Terms

In SAP E-Sourcing 5.x, payment terms do not conatin any data that identifies them as SAP ERP-integrated payment terms. Therefore, all these payment terms are treated as local payment terms during upgrade. After upgrade, the SAP ERP-integrated payment terms must be updated with the appropriate SAP ERP business system information.

### **Procedure**

1. Identify the list of Payment Term objects in the system that are currently local and should be replicated objects from ERP by customer's knowledge.

2. Construct a CSV file with the following fields:

#### Table 21

Field	Description
EXTERNAL_ID	This should have the external IDs of the payment terms that are currently local and that need to be converted to replicated data from certain external business system.
BUSINESS_SYSTEM	This should have the external business system's ID, to which the data is converted.
CONVERT_TO_REPLICATED	This is a flag to indicate whether the data in the current row needs to be converted. TRUE means conversion is needed. If this field is blank, the default value is FALSE.

- 3. Log in to system setup as a user who has master data super user rights with the permission to edit integrated master data.
- 5. Create a new import, and the import process is the same as normal data import:
  - 1. Choose the constructed CSV file.
  - 2. Choose the Payment Term object.
  - 3. Start the data import.

During the import process, the specified data in the CSV is converted to replicated data from the specified business system.

# 6.6.2.11 Update References to Business System Object

After you have updated the business system object, you must update all references to this object with the new display name.

## **Procedure**

#### 1 Note

If you can, shut down the SAP Sourcing server before executing these steps, because it is possible for users to overwrite changes made by the processor and for the processor to overwrite changes made by a user when interactive users and the processor run concurrently. If you can't shut down the SAP Sourcing server, you should execute these steps at a time when you have minimal interactive user activity.

- 1. From a command prompt, go to the /bin installation directory and enter **dbimport** to start the DB Importer utility.
- 2. On the Setup tab, select the fciinstall.jar file.
- 3. Navigate to the /scripts/product directory and select the synchronize\_object\_references.xml script file.
- 4. Back on the *Setup* tab, open the input help for the *Context* field and choose the enterprise context for which you want to update the references to the external system.

- 5. As user name, enter the enterprise manager user **enterprise** and enter the appropriate password.
- 6. On the Script tab, right-click Synchronize External System References and choose Run.
- 7. On the *Script* tab, verify whether the script run was successful (green checkmarks) or whether there were any errors (red crosses).

# 1 Note

When this step has successfully completed, a large green check mark appears in the bottom right corner of the window. Even if you see check marks next to all items in the main body of the window, if you do not see the large green check mark at the bottom right of the window, this step has not executed successfully.

If there were any errors, stop the upgrade and contact SAP Support.

# 6.6.2.12 Reactivate Extension Fields or Objects That You Want to Retain

## **Procedure**

The deletion utility will delete any data in inactive SAP E-Sourcing 5.x integration extension fields. If you want to retain any of this data, this is your only opportunity to reactivate the extension fields to prevent the data from being deleted. This also applies to inactivated objects that are integration artifacts such as scripts.

If desired, you can also retain materials with re-parented plants, though we do not recommend this. (A reparented plant is a plant that has been reassigned in SAP Sourcing 9.0 to a different material object so that the material/plant assignment in SAP Sourcing is identical to the material/plant assignment in SAP ERP).

# 6.6.2.13 Run DB Importer Script to Delete Obsolete Data

When you are confident of the integrity of the data, we recommend running a DB Importer script to delete the inactive integration extension data. You are not compelled to run this script, though performance will be affected if you do not run it.

There are two bundles in this script. Neither of them has to be run, and you can run them individually. If you run both, you must run the first bundle before the second bundle because the second bundle deletes work tables that are needed by the first bundle. The only reason to run them separately is to examine the material data after the reparented materials are deleted, using the contents of the work tables to understand better what was deleted. (Reparented materials are the duplicate materials that were consolidated into one material object during the material migration.)

### **Procedure**



None of the scripts mentioned below are rerunnable. If you encounter errors, contact SAP Support.

- 1. Stop the application server.
- 2. Run the DB Importer script erp\_inactived\_data\_deletion.xml to delete the inactive integration extension data. You can find this script in the fcidoccommon\_es.jar file in the following folder:
  - com/sap/eso/doccommon/converters/migration51/script

The script erp inactived data deletion.xml imports the following scripts:

- o extension data deletion.xml
  - This script drops the extension tables with inactivated integration extension fields if there are no active fields in the table. If there are active fields in the table, only the columns associated with the inactive fields are dropped. The extension metadata for the dropped tables and columns is removed.
  - Each bundle in this script represents one object type. You can run each bundle independently of the others.
- o material data deletion.xml
  - This script deletes rows from the database table FCI\_MAS\_MATERIAL that represent the inactivated, reparented materials. This script then drops two temporary tables that were created during material migration.
- 3. Restart the application server.

# 6.6.3 Consider Manual Change to Default Queries

The default query of each of your query groups is retained during the upgrade. Suggestions for changing the default query are listed below. If you want to make a change, you can do so manually via the UI.

- In the *Purchasing Group* buy-side picker query group, the default query has changed from "All Purchasing Groups" to "Search Purchasing Groups by ID."
- In the *Payment Term* buy-side picker query group, the default query has changed from "All Payment Terms" to "Search Payment Terms by ID or Name."

# **6.6.4** Maintain Number Range for Business Documents in SAP ERP and SAP Sourcing

To ensure that the number determination on the SAP ERP system continues to work as before, you need to do one of the following:

- Apply SAP Note 1653988 on your SAP ERP system.
- Make sure that you have installed the SAP ERP support package corresponding to that SAP note.

Once you have done so, you can make use of the external number assignment for ERP business documents. This helps ensure that business documents shared between SAP Sourcing and SAP ERP will have the same ID in both systems.

# 6.7 Updating and Validating Custom Queries

# 6.7.1 Run Query Tester After Upgrade

Running the query tester will identify custom queries that have basic problems accessing the database.

This procedure should be followed for each enterprise context.

#### **Procedure**

- 1. Log on to SAP Sourcing as a user with system administration rights. The enterprise account can be used.
- 2. Choose Setup
- 3. On the System Administration tab, in the Administrative Reports section, choose Test Custom Query SQL Statements.
- 4. Wait for the report to finish execution. The report lists all custom queries that failed to execute, along with an SQL error message and the SQL string, if available. The *App Log* file can also be inspected for exception stack traces related to the errors.

# 6.7.2 Use FCI\_GET\_CONTEXT\_RESOURCE\_VALUE

## i Note

This step is required only if you are upgrading from SAP E-Sourcing 5.x. If you are upgrading from SAP Sourcing 7.0, you don't need to perform this step.

If you have used SQL function FCI\_GET\_RESOURCE\_VALUE in the past to find the string value for a localized resource for a specific locale, you must now use SQL function FCI\_GET\_CONTEXT\_RESOURCE\_VALUE instead.

## **Procedure**

Replace any existing usages of SQL function FCI\_GET\_RESOURCE\_VALUE with FCI\_GET\_CONTEXT\_RESOURCE\_VALUE. Do not use the existing SQL function FCI\_GET\_RESOURCE\_VALUE in any new custom query definitions or script definitions.

#### 1 Note

If you use SQL function FCI\_GET\_CONTEXT\_RESOURCE\_VALUE in a query that returns more than 1000 rows, it is likely that the time to execute the query will become unacceptable.

#### 6.7.3 **Upgrade Composition of URLs to List Pages**

#### **Procedure**

A custom guery can compose URLs to various internal or external destinations. If a custom guery composes a link to a list page of a business document, such as a query used in the TODO channel of a portal page, you follow these steps to ensure that the link to the list page works correctly:

- 1. Add the following URL parameter: rgaction=loadsavedsearch
- 2. Ensure that the named query (specified by queryName) is contained in the query group that represents the list page for the business document.

If you don't follow these steps, clicking the link will lead to an empty list page with the error message: The query cannot be executed



# Example

Your source system contains the following URL:

/contracts/contractlist?queryName=FCI-MyContractsActiveReqAttn

For this URL to work correctly in SAP Sourcing 9.0, you must ensure that this query is contained by the query group that represents the master agreement list page and upgrade the link to the following:

/contracts/contractlist?rqaction=loadsavedsearch&queryName=FCI-MyContractsActiveRegAttn

In rare cases, the customization goal could be to execute a named query in a list page that does not have any other queries or that has a limited set of queries that are appropriate for the situation. A new query group could be created for the business document with the Query Use (i.e., Purpose) field set to Search rather than List. (A custom query group with purpose List or Picker should not be created.) This new query group would be invoked by its unique name in the URL, using a parameter in this form: queryGroupName=<named-query-group>.

### **Replace Use of Master Data Name and Description** 6.7.4 Resource IDs

# Note

This procedure is required only if you are upgrading from SAP E-Sourcing 5.x. If you are upgrading from SAP Sourcing 7.0, you don't need to perform this procedure.

When you upgrade from SAP Sourcing 5.x to SAP Sourcing 9.0, the following localized master data is converted to multi-string master data to reduce the resource cache and to provide more direct access to the localized values.

- Company code
- Currency
- Currency ISO code
- ERP region
- External category
- External system

- Incoterm
- Location
- Material
- Payment term
- Plant
- Product category
- Purchasing group
- Purchasing organization
- Transaction type
- Unit of measure
- Unit of measure ISO code
- Vendor account group

Due to the removal of the display name ID and document description ID from some of the localized master data, check and, if necessary, update all custom queries using DISPLAY\_NAME\_ID or DOCUMENT\_DESCRIPTION\_ID column names.

## **Procedure**

- Run the query tester to find out which queries fail.
   For more information, see Run Query Tester [page 52].
- 2. Edit each failed query definition on the SAP Sourcing user interface.

# 6.8 Review and Adjust Newly Introduced System Properties

Logon as a user with administrative privileges to modify these properties.

## **To Configure Columns in PDF Reports**

You can adjust the number of columns used to generate reports in PDF format, by modifying the value of the system property userinterface, pdf.max.querycolumn.count. The default value is 16.

If your PDFs do not generate correctly, increase the value of this property to reflect the number of columns you need.

## To Ensure Optimal AJAX Refresh and Update Times

## Note

This step is necessary only if you are upgrading to SAP Sourcing 9.0 SP13 or higher.

Set the following system properties according to the values in this table:

#### **Clear Browser Cache** 6.9

After the upgrade or application of a patch, notify all users to clear their browser cache.

- 2. On the General tab, find the Browsing history section and choose Delete... Be sure to delete at least the temporary internet files.
- 3. Hit F5 to refresh the browser.

With the the line item detail pane replacing separate detail pages, many fields and controls have been moved to new locations. If you have customized affected pages, you should check to verify that your customizations are still functioning properly.

# 6.11 Migrating from Axis2 to CXF

In some cases, you may have developed custom implementations to provide or consume web services using Apache Axis2. SAP Sourcing now uses Apache CXF. Because there are conflicting Java classes in Axis2 and CXF, the Axis2 libraries have been removed from SAP Sourcing. As a consequence, you will need to migrate any Axis2 implementations to Apache CXF. This section describes how to perform the necessary migrations.

For more information, see the Apache CXF Web site at cxf.apache.org/docs/overview.html.

#### **Procedure**

## Migrate a Custom Web Service to Apache CXF

- 1. Remove Axis2 services.xml files from the WEB-INF folder.
- 2. Annotate the service with the @WebService annotation
